- * PAPER BOARD (CEREAL, SHOE, AND FOOD BOXES)
- * PIZZA BOXES
- * TOILET PAPER/PAPER TOWEL ROLLS
- * CARDBOARD EGG CARTONS
- * FILE FOLDERS
- * PAPER
- * BUSINESS CARDS
- * NON-WAX PAPER CUPS
- * RECEIPTS
- * ENVELOPES
- * LEDGERS
- * PHONE BOOKS
- * JUNK MAIL

PLEASE PLACE THESE ITEMS CURBSIDE ON FIBER WEEK!

ACCEPTABLE RIGID ITEMS

SOLID PLASTIC:

ANY PLASTIC ITEM WITH A RECYCLING SYMBOL AND NUMBER IS ACCEPTABLE.

EXAMPLES:

- * CONDIMENT BOTTLES
- * NON-RETURNABLE PLASTIC CONTAINERS
- * SPORTS DRINK BOTTLES
- * CLEANING AND LAUNDRY SUPPLY BOTTLES
- * BATHROOM ACCESSORY BOTTLES
- * ICE CREAM PAILS
- * BUTTER TUBS
- * YOGURT CUPS
- * WATER BOTTLES

METAL:

ALL STEEL, TIN AND ALUMINUM IS ACCEPTABLE.

EXAMPLES:

- * STEEL
- * TIN CANS
- * SOUP CANS
- * LIDS
- * POTS AND PANS
- * METAL BAKEWARE
- * ORIENTIAL TINS
- * COFFEE CANS
- * PET FOOD CANS
- * SILVERWARE

RINSE, REMOVE CAPS/LIDS AND PLACE IN YOUR RECYCLE BIN

LITHIUM ION, NICKEL-CADMIUM-METAL HYDRIDE, LITHIUM WATCH BATTERIES, LEAD ACID, ALKALINE-6 & 9 VOLT, AAA-AA-C AND D BATTERIES.

THE FOLLOWING ITEMS LISTED ARE NON-ACCEPTABLE IN THE CURRENT COUNTY RECYCLING PROGRAM. PLEASE PLACE THESE ITEMS IN YOUR HOUSEHOLD TRASH.

GLASS, WOOD, CHIP BAGS, STYROFOAM, PHOTO PAPER, PHOTOGRAPHS, WAX-COATED ITEMS, BUBBLE WRAP, PET FOOD BAGS, CHRISTMAS LIGHTS, POWER TOOLS, GARDEN HOSE, RUBBER ITEMS, BOX FANS, RUGS/CARPET, FOOD, PLASTIC FENCE, PLASTIC WRAP, VCR TAPES, DVD DISCS, FLOPPY DISCS.

NON-ACCEPTABLE ITEMS HAVE BEEN DETERMINED BY THE MARQUETTE COUNTY LANDFILL. IF YOU HAVE ANY QUESTIONS, COMMENTS, OR CONCERNS IN REGARDS TO NON-ACCEPTABLE ITEMS PLEASE CONTACT US DIRECTLY.
